4. DCR Revision Committee Report

Richard provided an extensive overview of the committee's proposed revision of the Oakbridge Declaration of Covenants and Restrictions (DCR), including incorporation into it of pertinent parts of the Supplementary Declaration of Covenants and Restrictions (SDCR).

The committee recommended that the Board advance to the general membership a 3-part proposal to:

- (1) Completely repeal the SDCR of 1979 April 10 that apply to the Oakbridge Community.
- (2) Renounce any responsibility for or control over Oakbridge Condominiums or Oakbridge Apartments that might have been expressed or implied by the DCR of 1979 April 10.
- (3) Adopt the amendments to the DCR of 1979 April 10 known as "Action 44".

5A. Board Recommendation

The Board considered whether to proceed by posting proposed amendments on website. Valeri moved to do so; Rachel 2nd; adopted without objection.

5B. Public Hearings

The Board determined that public hearings would be held via Zoom on Tue. June 6 at 7:00 and on Sat. June 10 at 1:00.

The Board authorized a first-class letter to be sent to all Oakbridge members inviting them to the hearings and providing notice that a ratification effort will begin shortly thereafter. Brent moved to do so; Jacob 2nd; adopted without objection.
